

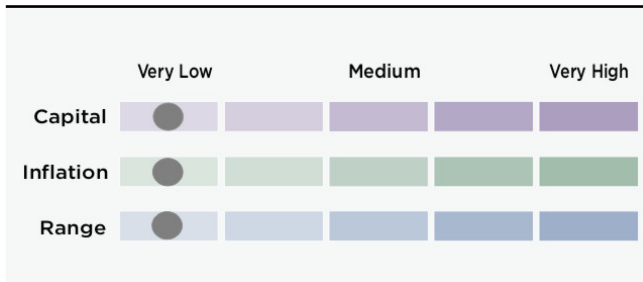
Investment Portfolio Profile

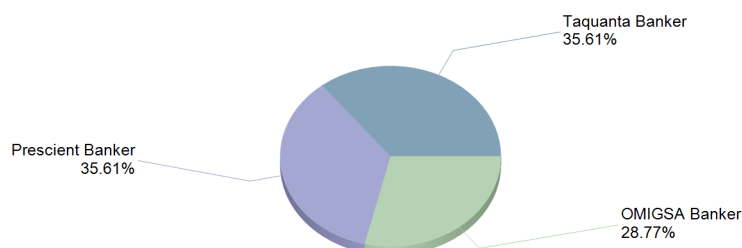

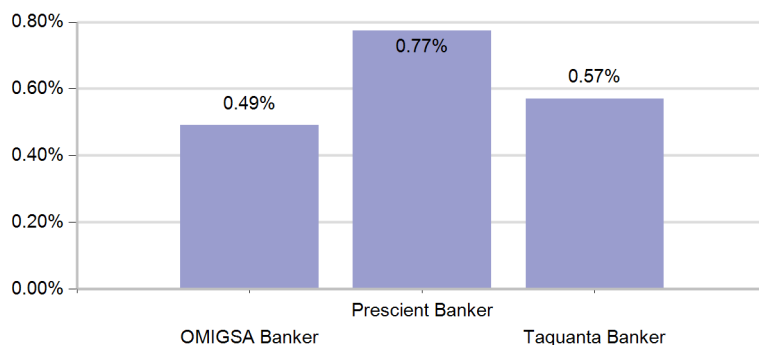
