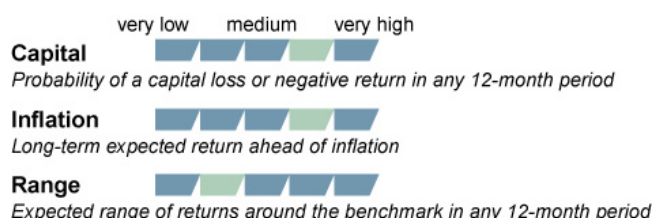

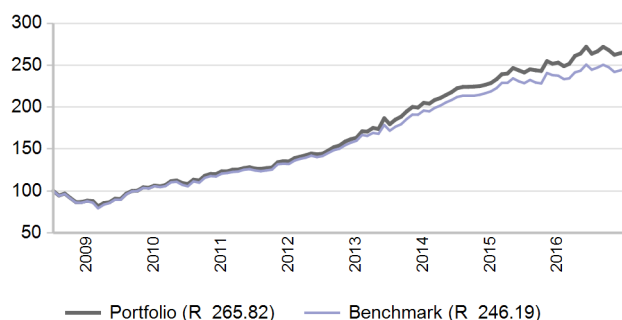
Portfolio description

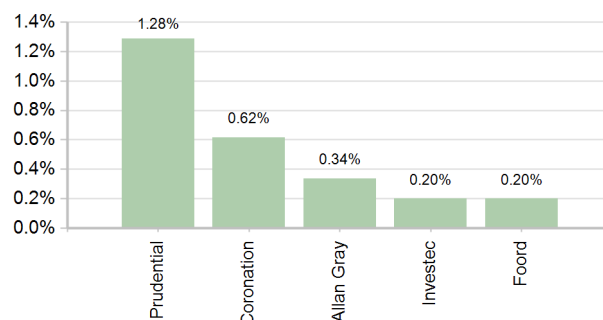
