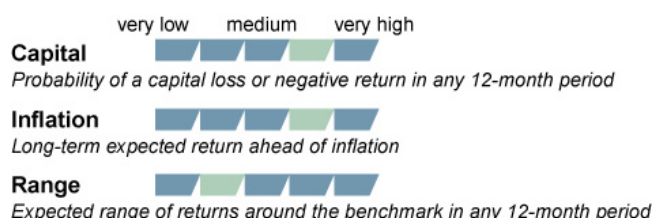

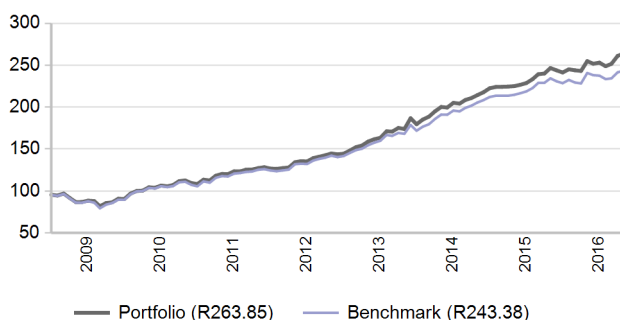
#### Portfolio description

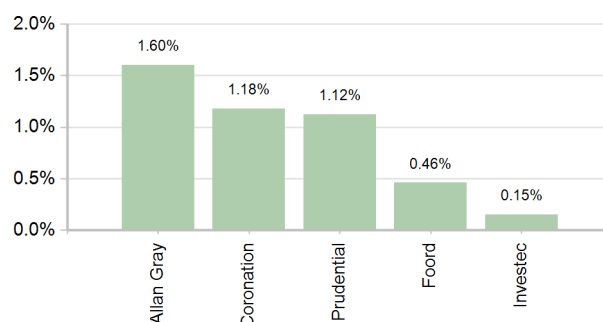
