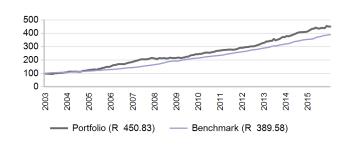
Portfolio description

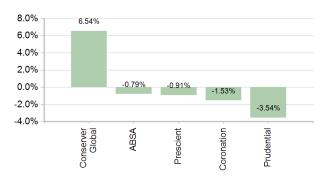
