

Portfolio workings

Investor contributions to the portfolio, together with the monthly fully vesting bonuses, are referred to as "book value". The market value of the underlying assets the insurer uses to back the capital guarantee is referred to as "market value". The "funding level" of the portfolio is expressed as a ratio of the market value to the book value. There are different scenarios under which an investor may exit the portfolio, namely a benefit claim, a withdrawal claim and a termination (partial or full) claim.

Benefit payments are made to provide retirement (including annuity payments), resignation and death benefits payable in terms of the rules of the fund invested in the portfolio. These payments, if meeting all the requirements, are made at book value. The amount payable is limited to the proportion that the fund's investment in the portfolio bears to the total assets of the fund. In the case of the individual member choice, the amount will be limited to the individual member's portion invested in the portfolio does not provide for the investment of money from surplus apportionment schemes.
